They reflect the credit risks of a fund's portfolio investments, the level of a fund's counterparty risk, and the risk of a fund's management ability and willingness to maintain current fund credit quality.

Management

Public Trust Advisors, LLC serves as the pool's investment adviser. The fund is subject to the general supervision of the Board of Trustees of VACo/VML. Principal is the custodian and VML/VACo Finance serves as the administrator for the fund.

Credit Quality

S&P Global rates VACo/VML (VIP) 1-3 Year High Quality Bond Fund 'AA+f/S1'. The 'AA+f/S1' rating is based on its analysis of the fund's credit quality, market price exposure and management experience. The 'AA+f' rating demonstrates that the pool's portfolio holdings provide very strong protection against losses from credit defaults. The 'S1' volatility rating indicates that the fund possesses an extremely low sensitivity to changing market conditions. As part of S&P Global's volatility

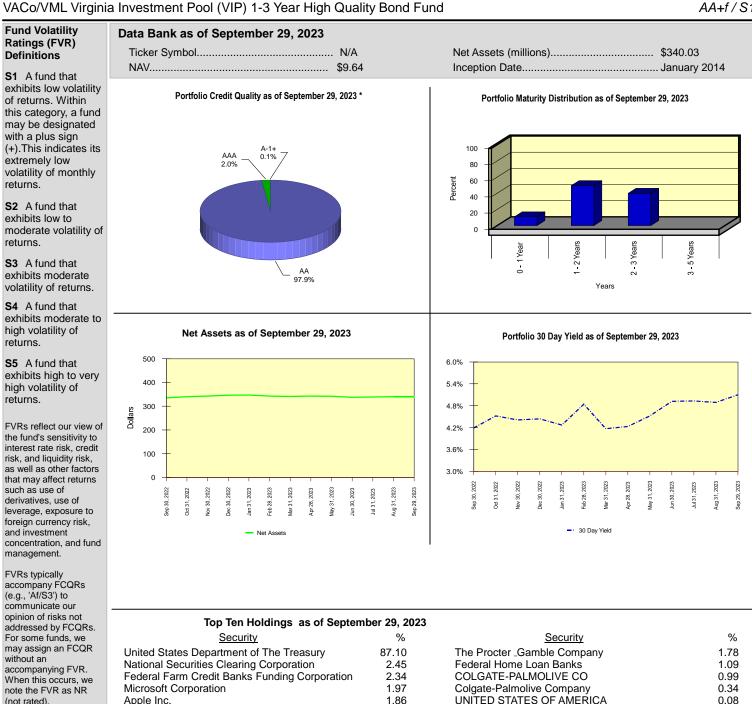
analysis, it assessed the management, portfoliolevel risk, target durations, and comparable return strategies of the pool. S&P Global monitors the fund on a monthly basis.

and invests in securities with greater potential returns and risk than those offered by typical money-market instruments. VIP invests in various security types, including U.S. Treasury notes and U.S. government agency securities, corporate bonds, and commercial paper that are typically rated 'AA-' or higher and have an average maturity of approximately one to three years.
